The Grant Water & Sanitation District provides for the conveyance and treatment of wastewater from its service area through contracts with the City of Littleton, Platte Canyon Water and Sanitation District and Southwest Metropolitan Water and Sanitation District. All applicants for sanitary sewer service from the Grant W&S District must first submit this application for approval to the entities listed in Sections A - C below, along with any additional documentation they may require. Payment of all applicable fees shall be acknowledged by an authorized signature for each entity on the lines provided. This form shall then be returned to Grant W&S District for final approval along with payment of the District's applicable fees, prior to a tap being made. All sewer taps must be inspected and approved by the Grant W&S District Engineer. The fee information provided on this application is subject to change and should be verified by the applicant prior to submitting for approval. This application is subject to the Grant W&S District's rules and regulations, including all present and future revisions thereto.

A. SOUTHWEST METROPOLITAN WATER & SANITATION DISTRICT SEWER TAP PERMIT FEE

Taps connected to the SWMW&SD Lilly Gulch Interceptor from the Southwest Health Park, pay \$450.00 PER Single Family Equivalent tap. All other sewer taps pay \$50.00 PER Single Family Equivalent tap. S.F. Equivalent taps for non-residential are calculated by SWMW&SD based upon water meter size. SWMW&SD tap fees are paid directly to SWMW&SD.
